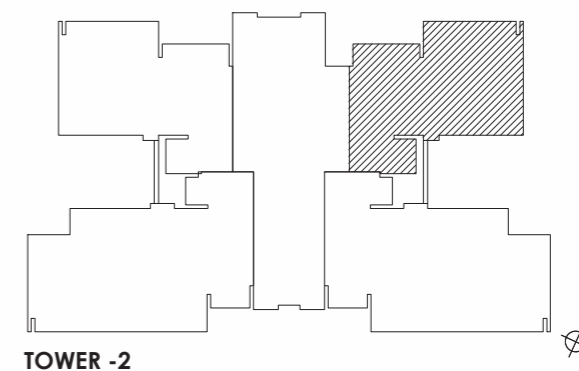
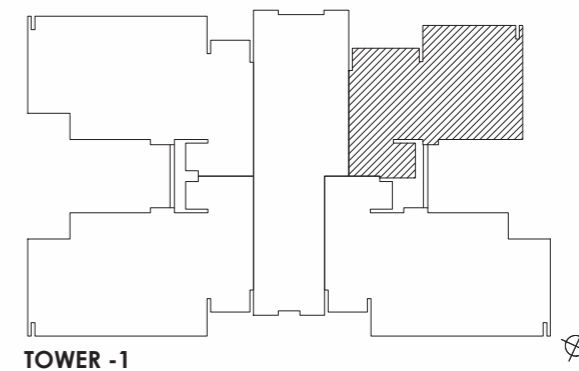


UNIT PLAN / 2 BHK TYPE 1



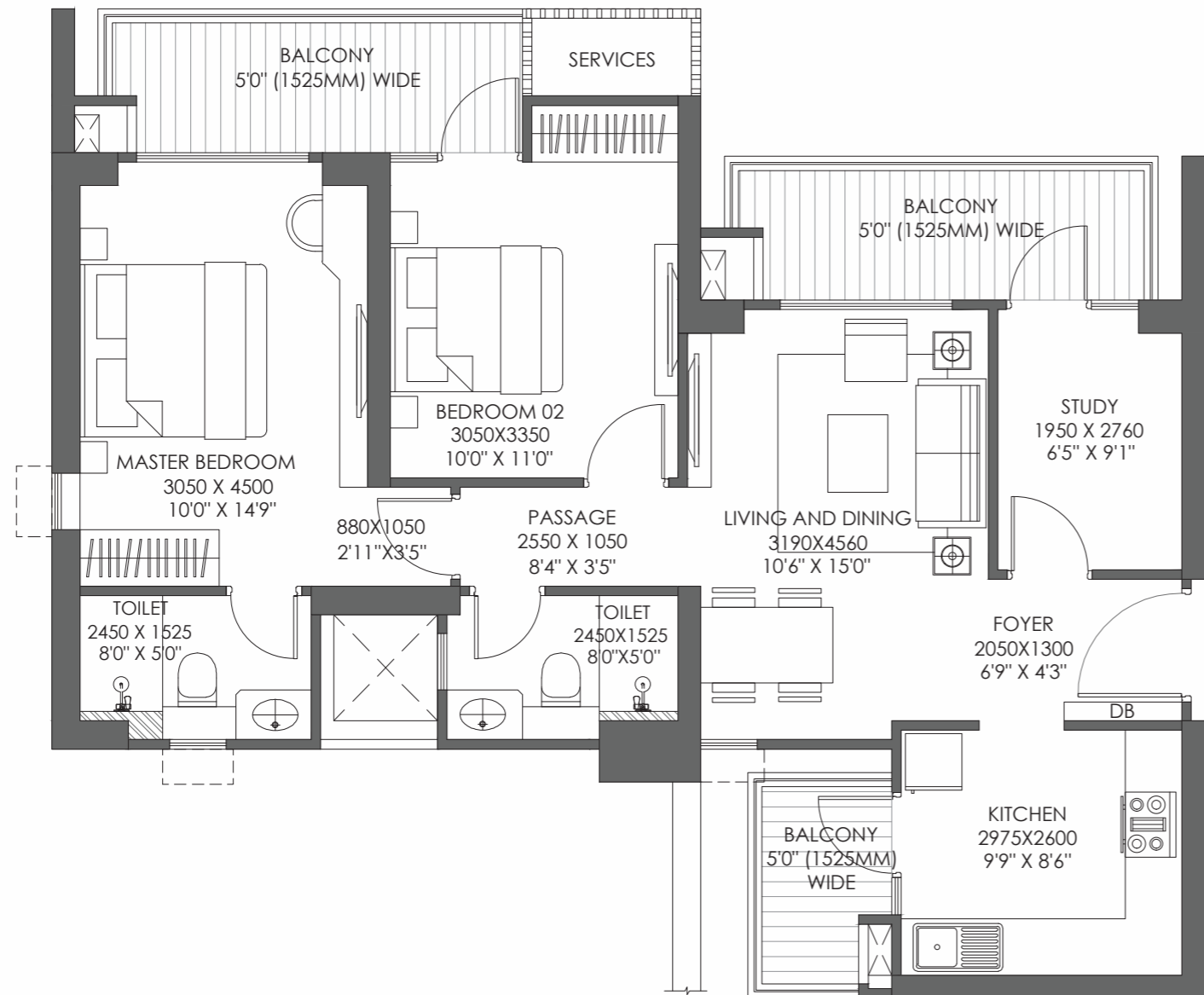

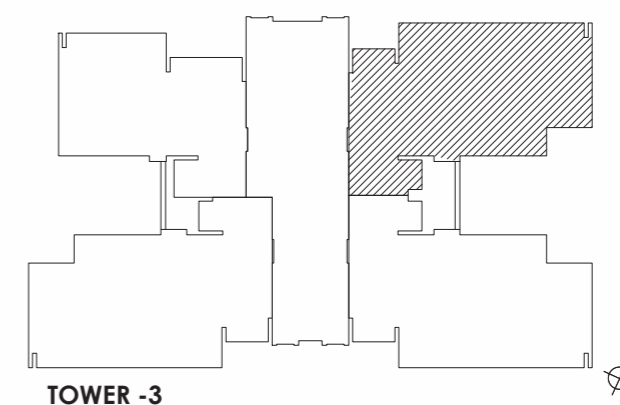


UNIT PLAN / 3 BHK TYPE 1

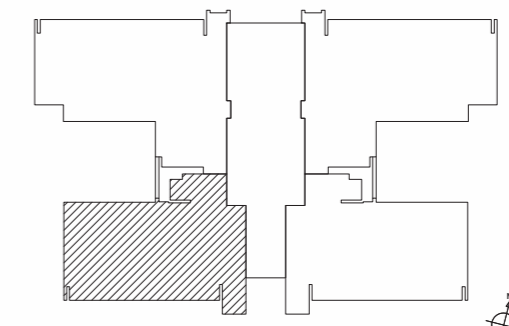


UNIT PLAN / 3 BHK TYPE 2

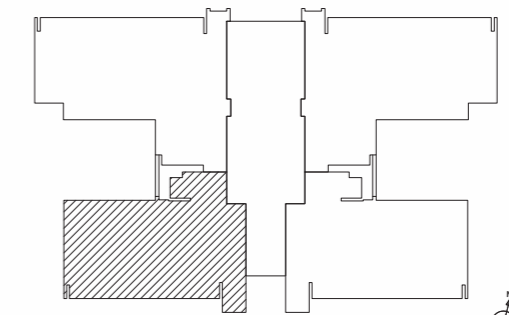

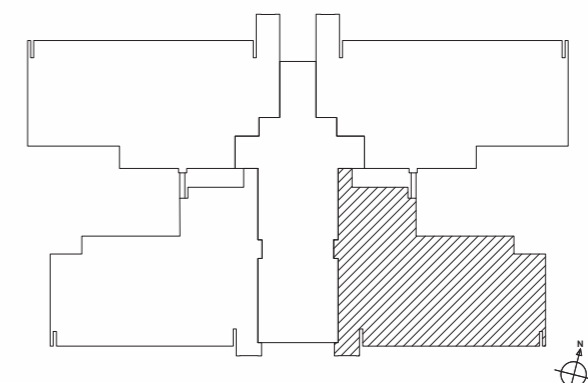


UNIT PLAN / 3 BHK TYPE 3
